Any application received after **25 May 2025** will not be accepted.
4. **Interview Date, Timing & Venue.** (a) Applicants **other than for Officer-in-Charge** category must reach Stn HQ, Yol at 0930h on **31 May 2025** for interview. (b) **Applicants for Officer-in-Charge** must reach Stn HQ, Yol at 0930h on **30 June 2025** for the interview to be held from 1000hrs onwards. Candidates must bring all the Original Certificates/Mark Sheets/Degree of 10th/Matric, 10+2 & Graduation/ Post Graduation/ Diploma/ Course, MD/ MS in Specialty Concerned, Work Experience, **Medical Fitness Certificate duly signed by CMO/SEMO**, Character Certificate duly signed by Tehsildar, Discharge Book, PPO, Service Records and Two Passport size photographs at the time of interview & also submit copies of the documents alongwith application in **TRIPLICATE**.
