Annexure "A"

<u>Eligibility criteria:</u> The applicant should be eligible as per provision contained in Resident Doctor Policy dated 24.12.2021.

- (i) Direct candidates and those regularly appointed GDOs who possess a MBBS Degree as recognized by NMC will be eligible for the post of Junior Resident. These posts will not be offered to any Post Graduate doctor /contractual GDOs.
- (ii) The selection will be made purely on the basis of merit of candidate in MBBS doctor examinations. First preference would be given to the direct MBBS Doctors who are not in the employment of the Government of Himachal Pradesh.
- (iii) Second preference would be given to GDOs whose spouses are working, in order of preference, as Senior Resident/Tutor Specialist or Faculty in the respective Government Medical College /Institution or in the State /Central Govt. (including semi-government /autonomous bodies fully or partially funded by the Government). In case there is more than one application for particular position ,the applicant having higher score in MBBS examination will be selected .

Terms and condition:

i)Junior Resident will be appointed against sanctioned post for a term of one year at a time. Extension beyond one year will only be allowed in exceptional cases and with the prior concurrence of the state Government.

iii)In case posts/vacancy of JR is not available in the preferred department, the applicant shall be allotted department as JR as per requirement of the institution and exigency of services in public interst.

ii)GDOs appointed on regular basis ,on their selection as Junior Resident will continue to draw pay and allowances/increments as admissible to them in their pay scale. MBBS doctors appointed in the direct category will get emoluments as may be prescribed from time to time by the State Government.

Removal:

Once appointed, the incumbents can be removed from the post at any time after joining in case of misconduct, misbehavior, acts of commission / omission, unbecoming of a public servant.

Similarly, if the performance is non -satisfactory as reported by the Head of Department during annual performance appraisals, the Principal shall hear the parties and forward the case to the Govt.for discontinuation of services ,if so required , along with his/her findings and recommendations.

A Junior Resident shall have to give one month prior notice or salary in lieu thereof to resign and the concerned Principal will accept the same.

Reservation:

The Reservation roster shall be applied for all posts as per rules applicable in the State of Himachal Pradesh. However if candidates of reserved category are not available in any category, then the post will be filled up form General category.

Age criteria:- As per State R&P rules & MCI/NMC Norms.

Important instructions:-

1) It is mandatory for the candidate to show all the original documents before the interview/scrutiny committee during personal appearance.

Incomplete applications shall not be considered at all and shall be rejected out-rightly. The

Principal will make no further correspondence with the candidate in the matter.

3) The application of eligible candidates shall be considered against advertised posts only.

- 4) The interested candidates are required to attend the walk in interview, personally/physically.
- 5) The eligible candidate should enclosed the certified/ self attested copies of the following certificates/documents along with application form:-
- a) Certificate of Matriculation or its equivalent examination (for verification of age).

b) Detail marks certificate of Professional examination (Degree).

c) Attempt certificate in respect of MBBS.

- d) Latest Registration Certificate from Medical Council.
- e) Certificate showing category i.e. Gen./SC/ST/OBC etc.
- f) Character certificate from competent authority.

g) Identity/Address proof.

h) Two passport size photographs.

Note:
